Members of Nursing Care Insurance

Nursing Care Insurance Division ☎ 23-6647 FAX 23-6520

Category I Insured Person (Persons age 65 or older)

【Eligibility】 Bedridden, dementia, or other patients who need nursing care in daily life can receive insurance benefits.

【Premium cost】 The amount of premium is calculated based on income. Premiums can be paid through automatic withdrawal from one's pension or with the use of a payment notice.

Category II Insured Person (Persons age 40 to 64 with medical insurance)

【Eligibility】 Patients satisfying the following requirements can receive insurance benefits: needing nursing care due to one of the 16 specified diseases, including pre-senile dementia and cerebrovascular disease.

【Premium cost】 Varies depending on the insurance one is enrolled in. For more information inquire with your insurance provider.

Procedures for Receiving Insurance Benefits (Nursing Care Services)

【Step 1】 Application

Please have the relevant person or a family member submit an application for certification of nursing care need (*yōkaigo-nintei*) / support (*yōshien*) to City Hall (*shiyakusho*) or a branch office (*shisho*) (Services at branch offices exclude new applications and renewal applications for support 1 and 2). (First-time users, please contact your local integrated care center).

【Step 2】 On-site survey

After an application is received, a municipal investigator visits the applicant’s home to check the person’s physical and mental condition as well as level of independence in everyday life. An opinion from the family (personal) doctor will also be sought in writing.

【Step 3】 Decision

An Okazaki City Council for Certification of Nursing Care Need is held. Based on the examination results and the doctor’s opinion, experts will decide the level of nursing care needed and will notify the relevant person of the decision.

Support Services

Preventive Care/Dementia Prevention Courses

【Description】 Exercise, nutrition improvement, oral function improvement, and other preventive care and dementia prevention courses are held.

Iki-Iki Club/Fureai Kenkō Club

【Description】 Exercise classes and recreational activities for dementia prevention are available as a community service at local school-district meeting centers and other institutions (ages 65 and above.)

Okazaki Gomanzoku Exercises

【Description】 Six types of muscle training exercises using weights, conducted at least once a week. Support provided for group start-up.

【Application】 At the Senior Citizens' Welfare Division or Local Comprehensive Support Center.



Partial Subsidy for Home Modification Expenses

【Intended for】 Mainly persons receiving nursing care insurance benefits

【Description】 The maximum amount of subsidy is 200,000 yen per household. Subsidy is only granted once. Some modification work may not be covered. It is necessary to submit an application prior to the commencement of work.

Presentation of Longevity Celebration Gift

【Description】 A gift to respect the aged and celebrate their longevity is presented to residents Okazaki as of September 1 of the year they will turn age 87; or age 99 or older.

Elderly Dementia, etc. Patient Pre-registration System

【Intended for】 Those with dementia who are feared may wander or get lost.

【Description】 By registering in advance, help in monitoring and, in the event of an emergency, searching for individuals affected by dementia can be provided at the community level.

Welfare Service for Seniors Cared for at Home

Subsidy for Purchasing Nursing Care Products (Diaper Voucher)

【Intended for】 Persons aged 40 or older who satisfy the following requirements: cared for at home, needing to wear diapers all the time, requiring nursing care level 3, 4, or 5 (*yōkaigo* 3, 4, or 5), and exempt from paying local resident tax

【Subsidy】 3,000 yen worth of tickets per month (Vouchers to purchase disposable diapers at designated shops are issued.)

Special Benefits for Bedridden Seniors Cared for at Home

【Intended for】 Seniors aged 65 or older who satisfy the following requirements:
Individual is cared for at home, and requires level 4 or 5 nursing care (*yōkaigo* 4 or 5), and exempt from paying local resident tax

【Benefits】 5,000 yen per month (Benefits are paid in April and October.)

Washing & Drying Futon, or Bedding Rental (One or the other)

【Intended for】 Persons satisfying requirements for receiving Special Benefits for Bedridden Seniors Cared for at Home (see above)

【Description】 Washing and drying of whole futon 5 times a year for free, or lending of futon set and exchange of futon for free once a month.

Voucher for Visiting Haircutting Services (Travel Expense Subsidy)

【Intended for】 Persons satisfying requirements for receiving Special Benefits for Bedridden Seniors Cared for at Home (see above)

【Subsidy】 A 2,000 yen voucher (for traveling expenses) up to six times a year.
Contact the specific establishment for the price of the haircut.
Costs in excess of 2,000 yen are borne by the user.

Senior Day Care “Fureai” Service

【Intended for】 Those 65 years old or older and are not receiving nursing care insurance benefits. (Only in Nukata area)

【Description】 “Fureai” Day Service Center (Kashiyama-chō) may be used up to 3 times per month.

【Charges】 300 yen (per visit): Cost borne by the individual
500 yen (per visit): Cost of lunch

Installation of Emergency Call Unit (Rental)

【Intended for】 Persons aged 65 years or older who are living alone and can be expected to have difficulty calling for assistance in the event of an accident or emergency.

【Description】 An emergency call unit is installed to the home telephone. This unit enables people at home to contact the call center in an emergency.

Meal Delivery and Check-in Service

【Intended for】 Households with persons aged 65 or older with certification of long-term care need (*yōkaigo nintei*) (must meet shared-household requirement) or households with only persons 75 years or older. Please contact the Senior Citizens' Welfare Division for details.

【Description】 A designated contractor delivers lunch or dinner (dinner in Nukata area) and confirms the well-being of the service user.

【User Fees】 350 yen per meal

Meal Delivery and Check in Service (for seniors alone during daytime)

【Intended for】 Persons aged 65 or older with certification of nursing care need (*yōkaigo*) 1 through 5 who are alone during the day (must meet shared-household and income conditions)

【Description】 A designated contractor delivers lunch (dinner in Nukata area) and confirms the well-being of the service user.

【User Fees】 350 yen per meal

Community General Support Center (21 Centers in Okazaki)

Community General Support Centers provide local seniors with comprehensive support in terms of nursing care, welfare, health, and medical care. Support services are provided by care managers, public health nurses, and social workers in their specialized field with regard to the following issues: introduction of nursing preventive care programs and care plan creation, consultation on welfare services and nursing care, introduction of conservatorship system, and support for prevention/detection of abuse. The relevant center depends on residential area. Home visit service is also available so feel free to consult us. The first consultation will be accepted at any center and may be handed over to a more relevant center, if necessary.

Services for the Disabled

Allowances and Subsidies

Disability Welfare Division ☎ 23-6154 FAX 25-7650

Handbooks for the disabled (*Shōgaisha techō*)

Handbooks for the disabled are necessary for receiving various welfare services.

Welfare benefits for the mentally and/or physically disabled (*Shinshin shōgaisha fukushi fujoryō*)

This service is for persons with a Physical Disability Certificate (*shintai shōgaisha techō*), Medical Rehabilitation Handbook (*ryōiku techō*), and Mental Disability Certificate (*seishin shōgaisha hoken fukushi techō*). Limitations apply based on age and income. Does not apply to compulsorily institutionalized persons.

Allowance for the disabled in need of special care (*Tokubetsu shōgaisha teate*)

This service is for severely disabled persons aged 20 or older, needing special nursing care in their daily lives. Limitations apply based on income. Does not apply to those hospitalized (for three months or longer) and institutionalized.

Welfare allowance for disabled children (*Shōgaiji fukushi teate*)

This service is for children younger than 20 years old with a Physical Disability Certificate (*shintai shōgaisha techō*) of grades 1 or 2, a Medical Rehabilitation Handbook (*ryōiku techō*) of rank A (IQ of up to and including 20), or other children with equivalently severe disabilities (a medical certificate must be attached.) Limitations apply based on income. Does not apply to recipients of the disability basic pension (*shōgai kisonenkin*) and institutionalized persons.

Allowance for the severely disabled at home (*Zaitaku jūdo shōgaisha teate*)

This service is for those with a Physical Disability Certificate (*shintai shōgaisha techō*) of grades 1 or 2, a Medical Rehabilitation Handbook (*ryōiku techō*) and an IQ of up to and including 35, or those with a Physical Disabled Certificate and a Medical Rehabilitation Handbook and an IQ of up to and including 50. Limitations apply based on age and income. Does not apply to recipients of the allowance for the disabled in need of special care (*tokubetsu shōgaisha teate*) or welfare allowance for disabled children (*shōgaiji fukushi teate*), and hospitalized (for three months or longer) or institutionalized persons.

Mutual aid system for supporting the mentally and/or physically disabled (*Shinshin shōgaisha fuyō kyōsai seido*)

In this system, guardians of the mentally and/or physically disabled (including children) are required to pay a certain amount of premium. In the event of the guardian's death, a pension will be paid monthly to the relevant disabled person. In the event that a disabled person (including children) predeceases the guardian, a lump sum benefit will be paid according to the enrollment period.

Special child rearing allowance (*Tokubetsu jidō fuyō teate*)

This service is for persons rearing children younger than 20 years old with a moderate or severe mental or physical health condition. Limitations apply based on income. Does not apply to child recipients of the disability pension (*shōgai nenkin*) and institutionalized children.

Taxi subsidy for disabled persons (*shōgaisha takushī ryōkin josei*)

Taxi subsidy vouchers are provided for those with a Physical Disability Certificate (*shintai shōgaisha techō*) of grades 1, 2 or 3, Medical Rehabilitation Handbook (*ryōiku techō*) of ranks A or B, or a Mental Disability Certificate (*seishin shōgaisha hoken fukushi techō*) of grades 1 or 2. Does not apply to those who have received a partial or full exemption from paying the vehicle/light motor vehicle taxes.

Welfare services for disabled persons (*shōgai fukushi sabisu*)

Services such as home help and the use of relevant institutions are available as needed for the following persons: those with a Physical Disability Certificate (*shintai shōgaisha techō*) or Medical Rehabilitation Handbook (*ryōiku techō*); those considered to have an intellectual disability (Mental Disability Certificate (*seishin shōgaisha hoken fukushi techō*), a designation of support for persons with disabilities (psychiatric outpatient), or a medical examination form is required); and those with one of the intractable diseases designated by the Japanese government.

Children's Facility Support Service (*Jidō tsūsho shien sabisu*)

Those under 18 years old with a Physical Disability Certificate (*shintai shōgaisha techō*), Medical Rehabilitation Handbook (*ryōiku techō*), or Mental Disability Certificate (*seishin shōgaisha hoken fukushi techō*); those whose need of medical treatment and educational services for intellectual disabilities has been recognized by a medical institution or other specialist institution, and those designated as having an intractable disease may use the in-facility services as appropriate to their needs.

Medical Subsidies

Medical expense subsidy for the mentally and physically disabled (*Shinshin shōgaisha iryōhi josei*)

A partial subsidy for medical expenses from treatment provided by insurance is available for the following persons: those with a Physical Disability Certificate (*shintai shōgaisha techō*) of grades 1, 2 or 3 (including patients with grade 4 kidney dysfunction or grade 4, 5 or 6 progressive muscular atrophy), persons with an Medical Rehabilitation Handbook (*ryōiku techō*) of rank A, or of rank B and an IQ up to and including 50, and persons diagnosed as having symptoms of autism.

Medical expense subsidy for those with intellectual disabilities (*Seishin shōgaisha iryōhi josei*)

A partial subsidy of medical expenses (excluding periods of hospitalization) for those approved for self-support medical care (*jiritsu shien iryō*) (psychiatric rehabilitation (*seishin tsūin*)) who are included in Mental Disability Certificate (*seishin shōgaisha hoken fukushi techō*) grades 1-3 (equivalent or greater than employees' disability pension grade 3, #13 (*shōgai kōsei nenkin 3kyū 13gou*)).

We provide consultation and necessary assistance so that people with disabilities can lead independent daily and social lives.
